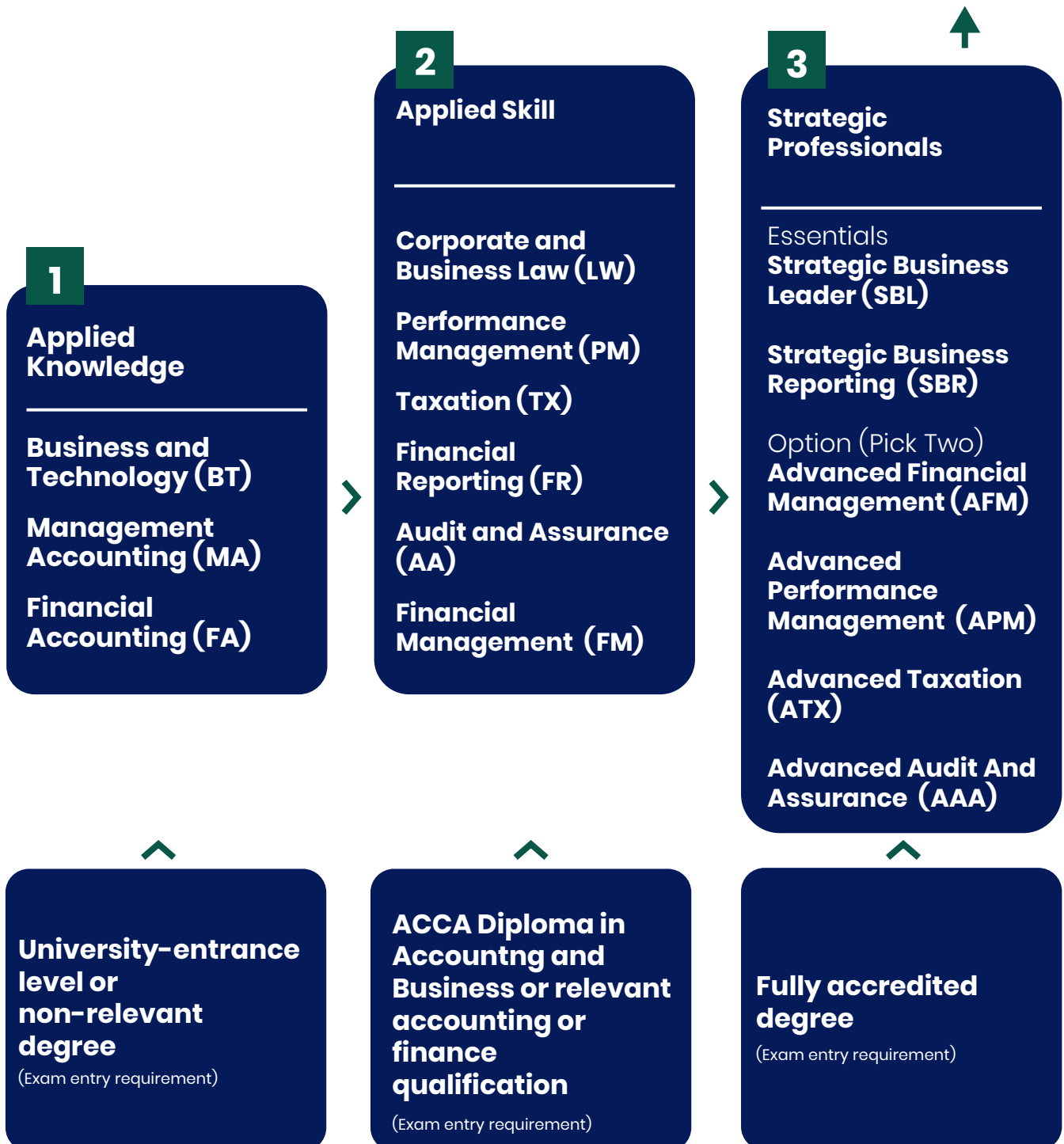

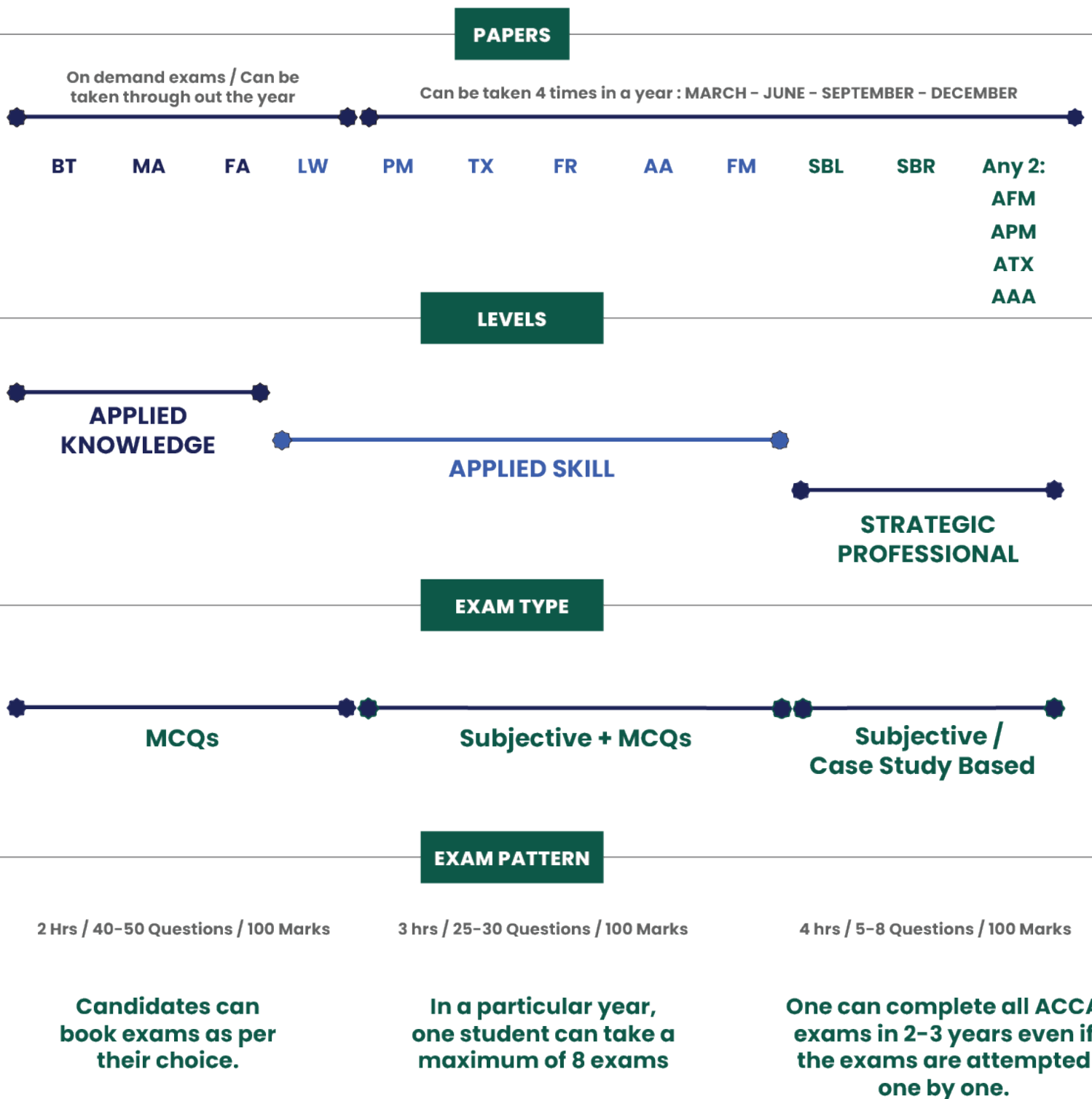

# What are the exemptions for the ACCA exam?

Those with qualifications higher than 10+2 are eligible to get exemptions on some specific papers, and they don't need to take the exams for those papers.

## **BCom, BBA, MCom, MBA**

Get an exemption up to 5 specific papers

## **India CA IPCC qualified candidates**

Get an exemption of up to 6 or more on particular papers

## **Qualified CA from India**

Get an exemption on 9 specific papers

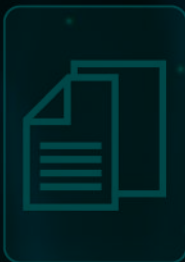

ACCA offers multiple entry points to suit learners at different stages of their academic or professional journey. Our team provides personalised guidance to evaluate your profile and recommend the most appropriate starting level.

## Minimum Class 12 (Commerce/Maths stream)

65% marks in each English and Accounts/Mathematics, and overall 50% marks.

## After Graduation (BCom/BBA/BMS)

Eligible for Skills Level with potential exemptions based on your degree.

## After Post-graduation (MCom/MBA)

May qualify for further exemptions. Start at Skills or Strategic Professional Level.

## With Professional Qualifications (CA, CS, CMA India)

Eligible for maximum exemptions. Directly enter at the Strategic Professional Level.

Use the ACCA Eligibility Checker to see if you meet the ACCA Qualification entry requirements.
